## **PROGRAM:**

Following an endorsement of the Rotary Foundation and an explanation of ways to consider long term support **Greg Bartz** put on his District 5060 Membership Team Leader hat to report on the District's initiative to increase both the size and level of activity of it's members. The strategy is to focus on attraction and engagement of new members by promoting the core values of Fun, Service, Integrity, Leadership, Inclusiveness and Innovation. Clubs in the district need to look introspectively at their qualities and needs and develop individual plans for recruitment of new members and to ensure both current and new members are engaged, feel connected and enjoy their membership. The District currently has about 2820 members and has set a goal of 3000 members by 2020.

Greg promoted the need to make membership desired by those who believe in Service Above Self and explained that it begins with inviting friends or associates who may share our values; everyone should invite someone. He further explained that attract new members we must be an attractive club. Do we go beyond simply greeting guests and visitors at the door? Do we seek out and introduce ourselves to guests? Do we reach out to new members, welcome them and urge them to become involved in an Avenue of Service? As we seek persons of good character, good reputations and a desire to serve we should reach out to former Youth Exchange participants, Rotaract members, RYLA participants and Rotarians who have moved to our area. He made another pitch for "Fun" by reminding us that members who are not engaged do not stay. He emphasized activities such as our fund raisers, 5:01, Blood Drives, Bear'ly Open, theater night at Lakeshore Players, etc. as examples of our fun events that must be promoted. Greg closed with two more points: 1) He needs help at the District level and is seeking volunteers; and, "Never miss a chance to make the ask."
