Orientation, Introduction, Mentors, Committee Participation and Attendance

An orientation is required for all new members. The new member will be asked to provide a bio and picture at the orientation. Once the orientation is completed and the initial dues are paid, all new members are publicly introduced to the entire Rotary Club at a Tuesday lunch meeting. To assist new members with learning about Rotary, they will be matched with a mentor Rotarian and asked to participate on Committees with other new members. All Rotary members are expected to actively participate on at least one committee and to maintain 60% attendance. Attendance credit is given for attending weekly meetings, committee meetings, community service projects and meetings at other Rotary Clubs.
