Our program

Eileen welcomed Fishing Well scholars, introduced members of the Fishing Well commission, thanked the club for 7 years of support and provided highlights about the newer program at Elgin Community College, which began last year with a \$50,000 grant from out club. At the end of 2023, ECC had expended over \$33.000 of that initial grant. So far there have been 11 people who have completed the Commercial Driver's License program, all employed in well-paying jobs, and 9 automotive scholarships have been granted.

Brenda presented a report "Fishing Well by the Numbers" on the past year's experiences and accomplishments. Since 2016 when the program began, there have been 81 recipients at a total cost of \$327,808.17. For this past academic year (2022-23) 89% of the participants have been enrolled part-time and 11% full-time; 59% are first generation college students (first in their family to attend college). Their average age is 33 and 94% are female.

Fishing Well students had an average GPA of 3.41, while Harper's overall average is 2.89. During the fall semester 5 of our students attained a 5.0 GPA, including some of our guests with us today. Our students' persistence rate is 94% compared to the overall rate for Harper of 76%. So far, this academic year, the persistence rate is 100% for Fishing Well students.

This academic year (2023-24) there are 16 Fishing Well students, 7 of whom are new to the program. A total of \$52,000 has been awarded. Brenda is excited to be able to follow these new students from the beginning to their successful completion. Programs of study include a variety of medical specialties, as well as Early Childhood Education, HVAC, Information Technology, Paralegal Studies and Geographic Information Studies.

Roger and Bob F spoke about their experiences as mentors. The students at the meeting were invited to say a few words and Brenda shared an update about a few of the alums of the Fishing Well program.

Holly led us in the 4 Way Test and the meeting was adjourned.
