

## Soldier's Blood & Bloodied Money - Allen B. Clark

Allen Clark is a 1963 West Point graduate who served in Vietnam as a Military Intelligence Officer. He was involved in undercover intelligence operations with the Fifth Special Forces Group (the Green Berets).

On June 17, 1967, he was wounded in a mortar attack at Dak To Special Forces camp in the Central Highlands of South Vietnam. He required 15 months of hospitalization after amputation of both legs below his knees. He was awarded the Silver Star for Gallantry in Action, a Purple Heart, Bronze Star, Air Medal and Combat Infantryman's Badge. He is airborne-qualified.

From 1979-1981 he served as Special Assistant to Texas Governor Bill Clements. He also served as Assistant Secretary for Veterans Liaison and Program Coordination and then as Director of the National Cemetery System of the Department of Veterans Affairs. He retired in 2005 as the Public Affairs Officer of the Veterans Affairs North Texas Health Care System in Dallas.


