

Club Leadership

- Embrace Rotary Club Central and use this club management tool effectively
- Meetings should be a good representation of Rotary for all members and guests
- Familiar with Rotary protocol and procedures
- Club President for more than one hour a week.
 Don't be a 'gavel' president
- Good Communicator, communicate regularly with your members, Assistant Governor and District Governor
- Macro-manage, NOT Micro-manage



Be a Dynamic Leader

- Effective Club President = Effective Rotary Club
- Development of future Club and District Leaders; Rotary Leadership Institute (RLI)
- Club Self Analysis (RLI Part 2 has an excellent, thorough Club Self Analysis)
- Club Trainer, Club Assemblies; Develop a comprehensive Club Training program
- Effective Communication between Club Leaders,
 Club Members and District Leaders



Lead a Dynamic Club

- Review Club bylaws, do they reflect the current status/needs of the Club
- Review Club's Committee structure do they meet the current needs of the club
- Provide opportunities to develop stronger relationships among fellow club members
- Effective, realistic engagement of most members possible in a club program or function




