## **SPEAKERS' REVIEW by Faith Woodward**

Pam Leland, Executive Director of The Hickman spoke to us about their expansion project. Several members of our club have been involved with The Hickman through the years, **John Schwab** was the Executive Director of 28 years, **Shauna Yeldell** and **Deb Sparre** are currently on the board and **Linda Hicks** is a former board member.

Now licensed as a Personal Care Home, The Hickman was founded by Quakers in 1891. Committed to affordability, entry fees are not requested and residents in financial need can tap into their financial assistance fund.

Sharpless Hall will be coming down and the replacement architectural design that was approved is a three-story, gabled roof building that will fit into the neighborhood. The new building will include 71 residences with the first floor devoted to those needing secure dementia care. This level of care requires a higher ratio of staff to residents. Every 67 seconds someone develops Alzheimer's disease but only 45% are told of the diagnosis.

Pam shared some "fun" facts with us that were sobering, in 2015 various dementias cost \$226 billion and by 2050 will be \$1,1 trillion. Caregiving by family members was valued at \$217.7 billion in 2014.

The Hickman's plans for demolition met some opposition from those who felt the building had historical value. Rather than going to court, the group worked through collaboration and some help from **Carolyn Comitta**.

The land ownership also provided some challenges so an overlay amendment was established with the West Chester Friends School and West Chester Friends Meeting who share the "Quaker Block" with them.

Rather than displace any of their residents, The Hickman worked on an 18 month attrition plan that permitted them to move the last nine residents to the main Hickman building.

Demolition will be in the spring, construction in the summer, and completion by July 2017 is estimated.

Pam answered questions from the group about dementia, Personal Care versus Assisted Living, and the waiting list at The Hickman.
