### Sun City West Zymurgy Club Membership Meeting Minutes April 8, 2015 Approved May 13, 2015 Lecture Hall, R.H. Johnson Center

#### Meeting Called to Order:

A quorum being present, Randy Pace, President, called the meeting to order at 6:32 p.m., and presided.

#### Treasurer's Report:

There ensued an extended discussion concerning the Club's current and prospective financial condition, and its expected ability to pay money when due for the Club space expansion. Key points discussed included:

 $\rightarrow$  The importance of promptly making draft and approved minutes of membership meetings available to the members

 $\rightarrow$  The importance of promptly making minutes of board of director meetings available to the members

 $\rightarrow$  The importance of full financial transparency for the members, such as identification of the amount of specific expenditures.

Pat Rodzak made the following motion:

**RESOLVED:** That the treasurer's report as presented be, and it hereby is approved.

The motion was seconded. The members by voice vote unanimously approved the motion.

#### Membership Committee Report:

Pat Rodzak, the committee's chair, presented the committee's report. A copy of the report is attached to these minutes as Exhibit 2. She stated that the Club has 215 members as of April 8.

### **Events Committee Report:**

Donna Whiteside, the committee chair, presented the committee's report. She noted the upcoming "Dos de Mayo" event.

Sharon Weinblatt described the Recreation Centers' requirement for monitors

- $\rightarrow$  at the Club's room when in use, and
- $\rightarrow$  at Club events held on Recreation Centers' property.

She described the duties of monitors, and the materials which have been developed to assist and support monitors. She asked members to volunteer as monitors, by contacting her.

#### Marketing Committee Report:

Lynne O'Grady the chair of the committee, presented the committee's report. She described efforts now being developed to raise money for the Club through marketing:

- $\rightarrow$  A 3-tier sponsorship plan
- $\rightarrow$  Products from local commercial brewers
- → Advertising in a limited area of the Club's room
- $\rightarrow$  Fund raising events
- $\rightarrow$  A sanctioned chilli cook off.

### Equipment Committee Report:

Tom Schutt presented the committee's report. He stated that the Club is getting close to completing its brew system.

### **Unfinished Business:**

Randy Pace gave a PowerPoint presentation on the Club's new integrated website, called "Club Runner." It has the following functionality:

 $\rightarrow$  A location for information for members, such as minutes of meetings

 $\rightarrow$  A location for information about the Club for prospective members, with online membership application

 $\rightarrow$  Email from the Club to members, from members to the officers and committee chairs, and between members

- $\rightarrow$  A calendar of events, with the ability to register and pay online.
- $\rightarrow$  Member directory

Randy Pace described the Club's new Operations and Procedures Manual. He stated that it is a "living document" which the Club will change as we gather experience on what works, what doesn't work, and what needs to be addressed.

Randy Pace noted that the Club is continuing the pursue –

- $\rightarrow$  A program of financial donations and pledges to the Club
- $\rightarrow$  A beer excursion

#### **New Business:**

Carol Pace reminded the members that there is a wine tasting event on Friday. The details are on the Club's website.

Carol Pace asked for volunteers to support the members-only Grand Opening of the Club's expanded room on April 12.

The meeting was adjourned by general consent at 8:04 p.m.
