In short, however, we have had another expectedly quiet month. Revenues consisted mainly of Education classes in Wine/Spirit appreciation plus wine tasting from Wine 101. Several storage units were rented in September and we expect with the snow birds returning, the cooler spaces will be at a premium.

Expenses were few, consisting primarily of a \$700 deposit needed to secure the caterer for the Holiday Party in December.

The dollars in and dollars out leave us with a checking account balance of \$5,650 and the savings account unchanged at \$18,300.
