## THE DALKEITH ROTARY CHARITABLE TRUST REPORT – 31 August 2021

The Trust was authorised to commence operations on 27<sup>th</sup> June 2008, with four members of the Dalkeith Rotary Club as trustees. The Foundation was incorporated on 10<sup>th</sup> December 2008, and became trustee in place of those four members. The members of the Committee of Management are: Russell Hawkins (Chairman), Jason van Straalen (Vice-Chairman), Tim Humphry (Secretary-dalkeithrotary.trust@gmail.com), John Bolto, Ken Ilett (Treasurer), Tony Chien, Ron Wilson, Peter Marfleet, and Craig James.

The Dalkeith Rotary Charitable Trust is a Public Ancillary Fund registered with the Australian Charities & Not for Profit Commission (ACNC), and which has Deductible Gift Recipient status (Australian Taxation Office). As such it can receive donations that are "tax deductible" to donors. Whilst the Trust will only accept donations without attached conditions, donations will be accepted (minimum \$250) from persons expressing in writing, a wish to benefit to an ITEM 1 DEDUCTIBLE GIFT RECIPIENT Charity. The Trust's income is mainly from the Dalkeith Rotary Club Board, individual Club Members, and investments. The Trust is required to make minimum distributions each year to ATO approved charitable organisations, and equal or greater than 4% of its net asset value as at 1st July in the previous taxation year.
