How Have I Done?

For the current Rotary Year, in this busy month of June, journey's end is round the corner. We are heading home, coming into the home stretch. But for Rotarians, the end of this journey is but the beginning of the next. Indeed, our mission to serve others in need has no ending. June is but a prelude to July, the beginning of yet another Rotary Year

Be that as it may, this is a good, good time for us to take stock of our effort, our contribution – or lack of them – thus far this Rotary Year. It is a good time for some honest self-assessment, some self-evaluation, and some soul searching. It is always good, if at times difficult, to subject and submit oneself to close scrutiny and some self-examination. The results are often revealing; in many cases refreshing. The core question to ask: "How have I done?"

This process is applicable to all Rotarians, all along the line – right down from the RI President, District Governors, Club Presidents, and to the common member on the shop floor. No matter what your station is.

I know many of the top guns can bask and glow in the sunshine of success they have achieved; this is expected of our leading lights. How about the others? We are all in the same Rotary boat. Many too in the lower decks have done well, some extremely well. We know the path to success is never smooth. In between the fields of flowers and the rolling green, lush meadows, there are always the rocky terrain, the ravines, and the peaks to scale. So cases of the lack of success – or, to be more brutal, failure – will also dot the landscape.

It is from such a mix of experiences that we learn a lot of Rotary lessons as we make our Rotary journey. Failure is oft-times difficult and discouraging. But as is stated in the Good Book – failure leads, yes, to suffering; yet, suffering breeds endurance; and endurance character, and character, hope. Hope often leads to a new lease of life. Also, as one philosopher said, "Failure is success you have not achieved." Encouraging! The important thing is to be aware of it, to accept it, and to acknowledge it. This process leads to reliance, resoluteness, and resolution. In short, the "3A's" often spawn the "3R's". So it is not all gloom and doom if you feel you have been found wanting.

Our relentless pursuit of our "Service Above Self" goal is an example to many others. We often drive ourselves with that relentless purpose. We do not seem to let up, do we? Come what may. This drive is at times innate and intrinsic, a self-motivation without any expectation of any reward of any kind – be this mere gratitude or the more tangible kind. The success of our effort makes us feel good inside. This is reward enough.

In this journey of compassion and care for others, we are guided by "The Object of Rotary", "The Four-Way Test", and "The Guide To Daily Living", with which we are all familiar. But these are just guidelines and the directional signs showing what Rotarians should do and along which paths to take. The rest is up to us. We try our level best. But at the end of the day, we still should ask ourselves, "How have I done?" Indeed, "Have I been significant?"

"Doing well" and "being significant" are, of course, not just about Rotary service. Even more important, I feel, is their application vis-à-vis the family and our daily life in our businesses and professions. We know the importance of the centrality of the family. We know too how important it is for us to be doing well and significant in our work. So these are good and useful questions to ask ourselves often.

As I alluded earlier – we know many Rotarians who show drive and devotion to Rotary service quite beyond the call of duty. We know too others have fallen short. Whatever the situation is – be it in reference to the family, our work, or Rotary – the answers hinge on no one but ourselves. Oft-times we hesitate to ask the questions. That is a fact of

life. But the need to know the answers is there, because they should motivate us to do better. Asking oneself, "How have I done?" and "Have I been significant?" is a sort of conscience and character test. The great Rousseau once said, "Conscience is the voice of the soul; passions are the voices of the body. No wonder they often contradict each other."

The case rests – with us!

PS: Obviously the Club has done well – thanks to President Garry's leadership and certain outstanding Members. The keynote question asked is meant for the majority members – the "ordinary" and "shop floor" members, like me.

The Good Samaritan Award 2016/2017

President Garry called on Rtn Pia Bruce to announce the winner of the Rotary Club of Singapore's Good Samaritan Award 2017. Before doing so, Rtn Pia advised that The "Good Samaritan Award" was initiated as a project by the Club's 'Community Service Committee' in 1998; it has become an annual project of the Club.

The Award recognizes and encourages public spiritedness – of persons who often go well beyond the call of duty in their laudable effort to lend a helping hand to those in need.

The Award recognizes some of the following values in a Good Samaritan:

- Going the extra mile for other's and improve the quality of their lives
- Compassion for others
- Commitment to community and fellow human beings
- Courage in action and deeds

Rtn Pia noted that Ms Josephine Ng, co-founder of two social enterprises embodied these values. Her first social enterprise, Haute Alteration, provides training and employment opportunities to women in need; including single mothers, out-of-work women and matured women. Located at Mandarin Gallery, it provides high-quality apparel alteration services. The alteration boutique is recognised as one of the best in the region, with clients like Vera Wang, Berluti, Valentino, etc.

New Rasa Singapura, her second social enterprise, provides training and employment opportunities to persons with physical disabilities, individuals recovering from mental illness and the elderly. Located at Tanglin Post Office Building, it serves refined Singaporean cuisines. This enterprise simplifies work tasks and redesign jobs according to the abilities of each beneficiary.

Prior to being a social entrepreneur, Josephine co-founded an integrated marketing agency that provided marketing solutions to many Fortune 100 IT companies. The agency was subsequently acquired by an international marketing group in 2001.

Ms Josephine Ng was recognised by Prime Minister Lee Hsien Loong during his 2012 National Day Rally speech, for her initiative to provide more opportunities to the less fortunate. Ms Josephine Ng was also presented with the inaugural President's Challenge Social Enterprise of the Year award by President Tony Tan.

Repertory Theatre (SRT)

Topic: *"Forbidden City"*

In her introduction of Ms Charlotte Nors, Vice President Dr Hoon Sing Keow noted that Ms Nor came to Singapore, 17 years ago. She is a seasoned arts administrator passionate about Singapore Repertory Theatre (SRT) as a key contributor, building a culturally rich country and a diverse arts scene.

As the Managing Director of SRT, Ms Nor's focus is to ensure SRT continues to produce and present outstanding theatre and learning programmes servicing a large number of patrons of all ages. Working with SRT's Board of Directors she ensures that SRT lives up to the highest standards of good governance, whilst providing stable and engaged employment to the team.

She is a graduate of the DeVos Institute's International Arts Management Fellowship programme at the Kennedy Centre in Washington DC.

Ms Nors shared how SRT was operating as a charity in the arts with IPC status. She added that SRT is the largest producer and presenter of theatre in Singapore serving over 125,000 people a year. She further advised that SRT has for the past 24 years been a stepping stone for many theatre practitioners on and off stage, and the company is committed to continue

to provide such opportunities.
