PREAMBLE

Rotary is a worldwide service organization, with more than 1,200,000 members in more than 170 countries around the world.

The Rotary Club of Burlington Lakeshore Charitable Foundation was established in Burlington in 1991 to provide ongoing educational awards each year to deserving students who wish to pursue post-secondary education.

TYPES OF AWARDS

The following awards are granted annually by the foundation:

- Six Academic Scholarships of \$3500 each, to students pursuing or planning to pursue a Degree at the post-secondary level.
- The Vocational Studies Award of \$3500, in memory of Ron Mc-Dermott, to a student pursuing post-secondary vocational training through a recognized post-secondary institution or program (such as a community college or university program, a private vocational school course, an apprenticeship or a trade program).
- The Fine Arts Scholarship of \$3500 in honour of Leon and Betty Laron, to a student pursuing or planning to pursue either a degree or a non-degree post-secondary program in Visual Arts (such as painting, sculpture, ceramics, or photography) or Performing Arts (such as music, dance or theatre).
- The International Studies Scholarship of \$3500 in honour of Kan Nakazawa, to a student pursuing or planning to pursue a degree program in studies with an international focus and/or which leads to an international professional career.
 Examples of studies would include economics, political science, world peace, environmental science, climatology, and international law.
- The Educational Studies Award of \$3500 in memory of Bev Bowra, to a student pursuing or planning to pursue studies leading to a career as a teacher or educational administrator.

ELIGIBILITY

The applicant must:

- be a resident of Ontario with particular consideration given to those from the greater Burlington area.
- be applying to or enrolled in a postsecondary program or study.
- be in full or part-time attendance during the year following the award.

Note: Members of the Foundation and their immediate families are ineligible.

SELECTION CRITERIA

It is expected that each applicant will have:

- demonstrated leadership or organizational ability at a school, university, business or community level
- contributed in a volunteer capacity to improving the quality of life for an individual or group
- a past history of academic excellence
- letters of support from two sources, one of which attests to the applicant's academic success(es), the other expanding upon leadership, volunteer contributions and/or personal situation

Note: Particular consideration will be given to students with financial need, as well as to mature students who have overcome personal challenges in completing their high school requirements.

APPLICATION PROCESS

A completed application should consist of:

- the candidate's letter indicating which award is being applied for
- two letters of support referred to above
- a transcript of the last available secondary school courses taken and grades received
- a portfolio may be submitted in the case of a Fine Arts applicant

It is suggested that the candidate's letter be organized as follows:

- A. Personal Information
 - name, address, telephone number, email address
- B. Educational Information
 - brief outline of academic achievements
 - brief overview of educational and career goals and planned studies
- C. Leadership or Volunteer Contributions
 - a summary of contributions in these areas
- D. Financial and other Information
 - including evidence of financial need (such as family situation, insufficient savings, sources of funding from other awards, etc.) and any further information that may be of assistance to the Selection Committee
