Australian Banking Regulations

Last Monday, our guest speaker was Ian Gilbert, a Director of the Australian Bankers Association with particular responsibility for retail banking regulation. His background is in legal practice, before spending ten years in retail banking and then returning to legal practice specializing in insolvency. This led him to his current senior role at the ABA.

Ian started by admitting that he occasionally wears a bullseye shirt when presenting as a keynote speaker on behalf of the banking industry..... it seems that everyone likes to take a potshot at the banks and they are in many ways an easy target. The ABA represents a group of 24 banks with a 16 member Council.... chaired by Anna Bligh, former Queensland Premier.

Ian spoke very highly of Anna and the Council members, describing his work as very rewarding despite the "elephant in the room"..... which he described as the "implosion of trust in the Banking Industry". Despite the media focus on negative bank stories like corporate executive salaries and conflicts of interest with trailing commissions for advisers, Ian said that the industry regularly receives over 80% positive results in the Morgan satisfaction survey. He took a random survey in the room and the show of hands confirmed that percentage of satisfaction despite the odd horror story inevitably experienced and retold by some members.

Ian said there have been 37 inquiries into the banking industry since the GFC and no other sector is held to account so often and so rigidly for compliance..... "unprecedented scrutiny" was how he described it. An example of unbalanced media reporting is the recent decision by the four majors regarding ATM fees.... instead of presenting it as a good news story, most media reporters took the populist stance that "the bastards have colluded and will get it back off us in another way". The Greens want to have a Royal Commission into the banking sector and even the Federal Treasurer Scott Morrison when handing down the Budget, could not resist the comment about the Banks.... "you don't like them anyway do you?"

In defence of the industry he represents, Ian quoted a number of very impressive and compelling facts and statistics concerning the banks.... the people it employs (\$25 billion in wages and salaries), the tax it pays and of course the major part played with dividends and income to Super Funds (\$14 billion in taxes and \$26 billion in dividends).

There have been many recent initiatives to improve bank engagement with their customers including customer advocates in every bank. Ian also referred to the ABA initiated Independent Review into Product Sales and Commissions by Stephen Sedgwick, which related to bank staff who received payments for selling bank products like deposit accounts and credit cards. As Rotarians, we see the Banks actively supporting our programs and being far better corporate citizens through encouraging and supporting staff to become involved with community projects.

Australian Banking Regulations - Continued

Ian commented that in earlier times, such in the 1950s, the Government used to set lending rates and loan conditions, this changed from the 1980s and there now seems to be a loss of public confidence in many of the current market mechanism of finance. Legally there have been changes to the Code of Banking Practice with a federal levy on all four majors and acceptance of almost all recent recommendations about ethical behaviour, including protection for whistleblowers. Legislation is under consideration for a Bank Executive Accountability Regime (BEAR) to force withholding of senior executive benefits if they have not acting properly.... which would apply to all Authorised Deposit Taking Institutions, such as Building Societies. The ABA has the website www.betterbanking.net.au which explains many of the issues that Ian made comments about and that the banks are addressing.

Ian also talked about the concept of 'open financial data' where you own your financial data. This means that you can addon and integrate financial products around your 'open financial data' with various providers. This is already being introduced in the UK, but Ian noted that there are some issues of concern around privacy of the 'open financial data' that need to be addressed.

This was a most interesting and informative presentation by Ian as evident from the quality and scope of the questions from our members. We thank him sincerely for his time and his very informed coverage of a subject which is significant to us all.
