## Here's how it works:

- 1)** Any company or organization may choose to nominate up to two representatives to be active members of the Rotary Club of Troy.
- 2)** If the active member cannot attend all the meetings, a second, alternate, or multiple employee(s) of the company could also attend.
- 3)** If designated members leave your organization for any reason, simply transfer his or her membership to another member at no cost. What's more, the individual who leaves, may transfer his or her Corporate Membership to an Individual Membership for a one-time conversion fee of \$50.
- 4)** Dues would be \$220 year, paid in advance, plus one-time application fee of \$100. Additionally, for each meeting that a member attends he/she would be charged the existing fee for the meal
