Some Q&A on Foundation

from the November Centennial District news

You may ask, how is The Foundation structured? Good question. The Rotary Foundation is organized as a public charity operated exclusively for charitable purposes and is governed by a Board of Trustees. The operations of Rotary International, a member organization, are overseen by its Board of Directors.

Is Rotary considered a Non-Government Organisation (NGO)?

Yes, as a Rotarian you are member of Rotary International, a member of a service club organization of more than 1.2 million men and women, associated with more than 35,000 Rotary Clubs in 200 countries. ... you are part of an organization that is a non-political and non-sectarian international NGO. We, as Rotarians give service on a voluntary basis.

When did The Rotary Foundation commence and what funds does the Rotary Foundation have?

In 1917, Arch Klumph, one of the initial Rotarians suggested that an endowment fund be set up to allow **Rotary** "to **do** good in the world." It **has** grown from Arch Klumph's initial contribution of US\$26.50 to more than US\$1billion. It **has** one of the largest and most prestigious international fellowship programs in the world and is recognised as one of the top 3 charities in the world not only for what is achieved but also for one of the lowest costs, around 10%, to operate.

What happens when I donate to the Rotary Foundation?

When you give to **your charity** The **Rotary Foundation**, you are directly supporting Rotary's work. Your gift makes our service projects — projects that eradicate polio, promote peace, and develop communities — happen.
