- 1) Has served as a community leader and builder.
- 2) Holds or has held a position with discretionary authority in any worthy and recognized business or profession.

Membership Types in The Rotary Club of Hamilton Stoney Creek

Standard Active Membership

Participation as an active member of the Stoney Creek Rotary Club presents several advantages that include:

- participation in a service organization with a rich history capable of assessing and responding to a diverse range of needs within the community and our country;
- increased awareness of your community and its leaders through association with Rotary and the many programs that are supported by The Rotary Club of Stoney Creek;
- immediate access to the global Rotary network of Rotary clubs, partner organizations and charities.
- participation opportunities with Rotary's hands-on projects; and
- membership in an organization dedicated to assisting and supporting our community, national and international needs, and activities.

Standard active members are those who meet the requirements for membership, pay Rotary International (RI) dues, RI District 7090 Dues, and Club Dues. You are eligible to vote on club and district matters, are eligible to hold a club officer position and count in the club's membership numbers in Rotary' 7090 dues database.

Standard Active Membership fees include:

- 1. **Initiation Fee** is \$100.00 paid once on admission into the Club.
- 2. **Annual Club Dues** amount is \$200.00. This includes Rotary International (RI) dues and RI District 7090 dues. Annual Club dues are prorated according to the month a new member joins us.

3. Meeting costs are additional costs and are determined when the club should incur such expenses.

A potential new member must attend at least three (3) weekly Rotary meetings before their application can be submitted to the Board of Directors for review. The application is then circulated to the club membership and after 7 days the new member can be initiated into the club. He/she will then be billed for his initiation fee, yearly dues and balance of that quarter's breakfast costs.

Corporate Active Membership

Enhance your company's community exposure through the involvement of senior corporate executives. Corporate Membership Entitlements

Your corporation will have one primary (Standard Active) and up to two (2) associate members.

The primary member applicant and the club will participate in a screening process to make sure that there is a good fit for both organizations. Associate members will be selected by the primary member, once approved for membership. Your corporation will be able to replace a member as required. Should a primary or associate member leave the corporation, they may request to join the Club as an individual member.

Corporate Active Membership fees \$500.00 and includes:

- 1) 1 Yearly Membership.
- 2) Enrollment in Rotary International, Membership Internet Access and Rotary Magazine.
- 3) The enrolled member can send someone else as a replacement at meetings.
- 4) Inclusion of Company Logo on the Rotary Club of Hamilton Stoney Creek Website.
- 5) Meeting costs (meals) are additional costs and are determined when the club should incur such expenses.
