Rotary International, founded in 1905 by Paul Harris in Chicago, is a worldwide network of 1.4 million members in nearly 46,000 clubs who believe in the commitment to "Service Above Self." Rotary's purpose is to bring together business and professional leaders to provide humanitarian services, encourage high ethical standards in all vocations, and to advance goodwill and peace around the world. It is a non-political and non- sectarian organization open to all people.

- Currently working in a professional, proprietary, executive or managerial position or is retired from such a position.
- And/or a community member who has demonstrated a commitment to service through personal involvement in community affairs.

What are the Expectations or Commitments of a Rotarian?

Participation Commitment

Attend the weekly meeting, in person or on Zoom, Tuesday 7:00 to 8:30
 a.m. Make up missed meetings by:



- Attend another club's meeting, attend a committee meeting, work on a project, attend a District or International Rotary meeting or On-line e-club, assist in some aspect with the 365 Health Fair, Community Dinner, Thanksgiving dinner, literacy projects or 4 Way Test in the schools, sell Ice Melt Contest and/or Car Raffle, attend meeting on zoom.
- Join a committee.

Financial Commitment

- Dues are billed quarterly and include District and Rotary International dues, a Christmas party, a Club Transition dinner, administrative costs, conference and training stipends, and humanitarian requests.
- Membership is billed at \$200 per quarter and includes continental breakfast, tea, coffee and juice.
- An additional \$60/quarter adds a voluntary contribution of \$30 to our local Charitable Fund and
- \$30 to the Rotary International Fund. These appear on each quarterly statement. You are encouraged to make these tax-deductible contributions as these contributions support our grant and service projects.

The financial commitment needs to be met by the due date on your bill.

HOW TO BECOME A MEMBER OF ROTARY CLUB OF SUMMIT COUNTY ("THE PROCESS")

- You are requested to attend three meetings at you or your sponsor's expense, (\$12/breakfast). to get a "feel" for the club, its fellowship, activities and commitments prior to turning in your application.
- A Membership Committee member or a seasoned Rotarian will schedule a meeting for coffee or lunch to go into more detail about Rotary and our club.
- Complete a Membership Application online. Includes a short Bio of your credentials. Return forms to the Membership Chair: Dave Guignard, <u>davidguignard@mac.com</u> bring the \$ 50.00 application fee to a meeting.
- You need one Rotarian to Sponsor you and fill out a Sponsor form online and return to Dave Guignard, davidguignard@mac.com
- You are encouraged to go the websites of the Rotary Club of Summit County, www.summitrotary.com, District 5450, www.rotary5450.org, and Rotary International, www.rotary.org. Once you are inducted into the club you will receive a log-in and you can obtain additional information such as the Club Membership Directory.

The Membership Chair will present all forms to the Membership Committee and Board of Directors for approval.



- When approved by the BOD your name and Bio will be placed in our weekly Bulletin for 3 weeks.
- Upon approvals and publication in the Club Bulletin 3 weeks, you will be eligible to be inducted into Summit Rotary Club at a Tuesday meeting.

Your first quarterly dues bill will be prorated for that quarter.

After you have joined, you will give a short Classification talk to introduce yourself with your brief background at one of the meetings. You will be asked to join a committee and get involved with our projects as soon as possible.


