
## BEST OF FRIENDS HERITAGE ENDOWMENT FUND Rotary District 7090

Clubs** who make a minimum of \$1,000 contribution will be recognized on the district website in perpituity as a Founding Heritage Society Member and will have the opportunity to make a toast at the Feb 23, 2022 Foundation Pre-Gala. **Individuals** who make a contribution of *any amount* will receive credit towards their all-time giving and status towards major donor and Arch Klumph Society member status. **Individuals** who make a *minimum of \$1,000* contribution will receive a benefactor ribbon to append to a PHF or Rotary

pin. Note that the endowment program is not a qulaifying program for Paul Harris Fellowship and points are not awarded.
