R. Gordon R. McInally was educated at the Royal High School in Edinburgh and at the University of Dundee, where he earned his graduate degree in dental surgery. He operated

his own dental practice in Edinburgh until 2016. McInally was chair of the East of Scotland branch of the British Paedodontic Society and has held various academic positions. He has also served as a presbytery elder, chair of the Queensferry parish congregational board, and commissioner to the general assembly of the Church of Scotland.

Gordon joined Rotary in 1984 at age 26. A member of the Rotary Club of South Queensferry, he has served as president and vice president of Rotary International in Great Britain and Ireland. He has also served RI as a director and on several committees, most recently as an adviser to the 2022 Houston Convention Committee and chair of the Operations Review Committee.

Gordon says he looks forward to working with members to build new Rotary clubs and groups. "My vision is that Rotary should exist everywhere in a style to suit everyone who has the desire to be part of us and to help us do good in the world," he says.

He is a patron of the UK-based nonprofit Hope and Homes for Children and led a partnership between that organization and RIBI to support children in Rwanda who had been orphaned in the genocide there. He is a patron of Trade-Aid, an initiative of the Rotary Club of Grantham Kesteven, England, that provides sustainable humanitarian aid to individuals, families, and businesses in the developing world. He is also an ambassador for Bipolar UK, a national mental health organization. In August 2022, he was made a laureate of the Sino Phil Asia International Peace Awards Foundation.

In his free time, Gordon enjoys rugby, good food and wine, and stick dressing, the traditional Scottish craft of making walking sticks.

Gordon describes The Rotary Foundation as "the engine that provides the energy to do Rotary service." He and his spouse, Heather, also a Rotarian, are Paul Harris Fellows, Major Donors, Benefactors of The Rotary Foundation, and members of the Bequest Society.

Gordon wishes to dedicate his presidency to making the world a better place for his granddaughters, Ivy and Florence, and all the children of the world, to live and thrive.



Stephanie UrchickRotary International President-Elect 2023–2024

Stephanie Urchick is a member of the Rotary Club of McMurray, Pennsylvania, USA. She will serve RI as president in 2024-25. She has been an RI director and Rotary Foundation trustee. She has served RI in numerous

capacities, including as training leader, regional Rotary Foundation coordinator, and RI president's representative. In addition, Stephanie was a representative and member-at-large to three sessions of the Council on Legislation.

Stephanie has also served as chair of the Rotary Strategic Planning Committee and The Rotary Foundation's Centennial Celebration Committee, as well as a member of various Rotary committees, including the Election Review Committee and Operational Review Committee.

A Rotary member since 1991, Stephanie has participated in a variety of international service projects, including National Immunization Days in India and Nigeria. In Vietnam, she worked with clubs to help build a primary school and traveled to the Dominican Republic to install water filters. A student of several Slavic languages, she has mentored new Rotary members in Ukraine and coordinated a Rotary Foundation grant for a mammography equipment and a biopsy unit for a hospital in Poland. In its commemorative book, the Rotary Club of Krakow, Poland, noted Stephanie as a key figure for helping the re-birth of Rotary in post-Communist Poland.

Currently, Stephanie is helping to partner clubs and districts in the U.S. with Rotary clubs in Albania. Kosovo, and Ukraine for humanitarian and educational services.

Stephanie's professional background is in the higher education, consulting, and entertainment industries. She received her doctorate degree in Leadership Studies from Indiana University of Pennsylvania and has been recognized and awarded by The Rotary Foundation and numerous community and international organizations.

Barry Rassin

The Rotary Foundation Chair 2023-2024 The Rotary Foundation Trustee 2020–2024 Rotary Club of East Nassau Bahamas

Barry Rassin is a director and former president of Doctors Hospital Health System in Nassau, Bahamas, where he retired

after a 38-year career. He was the first fellow of the American College of Healthcare Executives in the Bahamas and was honored with the National Award of Health Hero by the Bahamas Ministry of Health and the Pan American Health Organization.

A Rotarian since 1980, Rassin served as RI president in 2018-19, when he advocated for closer partnership between Rotary and Rotaract clubs and presented the measure that broadened the definition of membership in Rotary International to include Rotaract clubs at the 2019 Council on Legislation. He has served RI in many other capacities, including as RI director, Rotary Foundation trustee and vice chair, chair of both the Finance and the Shaping Rotary's Future committees, RI training leader, and seminar trainer. In 2010, Rassin coordinated Rotary's disaster relief efforts in Haiti after a devastating earthquake. That included supervising the completion of 105 relief and development projects throughout Haiti that were made possible by the \$6.5 million raised by Rotary members worldwide. He is currently active on the Bahamas Rotary Disaster Relief Committee and working on relief efforts in the wake of Hurricane Dorian and the COVID-19 pandemic.

Outside of Rotary, Rassin chairs Volunteer Bahamas, a national program to create a culture of volunteerism in the country. He also helped found the Haiti National Clean Water, Sanitation, and Hygiene Strategy (HANWASH), a collaborative program to bring potable water and adequate sanitation to all the citizens of Haiti. In 2018, the government of the Bahamas named him as an Officer of the Order of Distinction.

Rassin has received the Service Above Self Award. He and his spouse, Esther, are Rotary Foundation Major Donors, Benefactors, Paul Harris Fellows, and members of the Paul Harris Society.



Mark Maloney The Rotary Foundation Chair-Elect 2023-2024 The Rotary Foundation Trustee 2021–2025 Rotary Club of Decatur

Mark Daniel Maloney is a principal in the law firm of Blackburn, Maloney and Schuppert, LLC, with a focus

on taxation, estate planning, and agricultural law. He represents large farming operations in the Southeastern and Midwestern United States and has chaired the American Bar Association's Committee on Agriculture in the Section of Taxation. He is a member of the American Bar Association, Alabama State Bar Association, the Alabama Law Institute, and is a past president of the Morgan County Bar Association.

He has been active in Decatur's religious community, chairing his church's finance council and a local Catholic school board. He has also served as president of the Community Foundation of Greater Decatur, chair of Morgan County Meals on Wheels, and director of the United Way of Morgan County and the Decatur-Morgan County Chamber of Commerce.

Maloney served as RI president during 2019-2020, when he presided over the first virtual RI Convention that was organized during the COVID-19 pandemic and emphasized strategies to grow Rotary. A Rotarian since 1980, he has also served as an RI director; Foundation trustee and vice chair; and aide to 2003-04 RI President Jonathan Majiyagbe. He also has participated in the Council on Legislation as chair, vice chair, parliamentarian, and trainer. He was an adviser to the 2004 Osaka Convention Committee, chaired the 2014 Sydney Convention Committee, and chaired RI's Operations Review Committee for four terms. Prior to serving as a district governor, Maloney led a Group Study Exchange to Nigeria.

He also served as Future Vision Committee vice chair; Foundation training institute moderator; Foundation permanent fund national adviser; member and vice chair of the Peace Centers Committee; member of the International PolioPlus Committee; and adviser to the Foundation's Water, Sanitation, and Hygiene in Schools Target Challenge Committee.

Maloney's wife, Gay, is an attorney in the same law firm and a member and past president of the Rotary Club of Decatur Daybreak, Alabama, USA. Both support The Rotary Foundation as Paul Harris Fellows, Major Donors, and Bequest Society members.



Pat Merryweather-Arges Rotary International Board Vice President 2023–2024 Rotary International Board of Directors 2022–2024

Pat Merryweather-Arges is a Rotarian from the Rotary Club of Naperville. She has a long list of service in her club, district, zone, and RI globally. She served as the Club

President and received her Club's Rotarian of the Year and Four Avenues of Service Awards. She has served the District as District Grants Chair, Rotary Foundation Chair, Diversity Chair and as District Governor of District 6450 (Northern Illinois) in 2012-2013. She has served as the Regional Rotary Foundation Coordinator, Zone 28-29 2016 Institute Chair, Chair of the 2018 Presidents International Peace Conference in Chicago, and COVID Task Force.

As a Rotarian Pat has traveled to over a dozen countries working on Rotary grants and programs and has attended Rotary Day at the United Nations and a Rotary Middle East Peace Conference in Turkey. She has immunized children against Polio in India, Nigeria, and Pakistan. Her grants and projects include WASH, microenterprise with solar ovens, and medical and healthcare missions. Pat has received the Rotary Foundation Meritorious Service Award and the Rotary International Service Above Self Award. Pat also is actively engaged with Rotary Fellowships and Rotary Action Groups.

Professionally, Pat is Executive Director of Project Patient Care where she works with patients, families, and caregivers to have their voice heard in health and healthcare through advocacy, public health policy, and collaboration with providers. She is a strong business development professional skilled in Nonprofit Organizations and has lead quality health improvement initiatives with the federal government and served in executive leadership roles in a hospital membership association. She also serves as chair or board member with several hospitals, healthcare, and community organizations. She serves on an expert panel of the WHO Patient Safety and Quality global plan.

Pat is married to George, a Rotarian, and they have four sons, three daughters-inlaw, and 7 grandchildren!

Pat and George are Major Donors, Paul Harris Society and Polio Plus Society members, and Benefactors to the Rotary Foundation.



Ghim Bok Chew Rotary International Director 2023–2025

Born in Singapore, Ghim Bok "G.B." Chew graduated in 1981 with an honors degree in computer science from the University of Liverpool, England, before returning to his home country to launch a career as a serial entrepreneur,

venture capitalist, and private equities fund manager. After opening his first business, an IT systems integrator, he took a bankrupt food processing company to an initial public offering after turning it around. Now semiretired, Chew maintains real estate and real estate management companies in Singapore, in addition to his fund management holding company.

Chew joined Rotary in 1996. Immediately after serving as district governor in 2013, he took on several zone and international roles, including assistant regional Rotary Foundation coordinator, assistant Rotary public image coordinator, Rotary coordinator, and chair of the zone institute committee. He is the Host Organization Committee chair for the Rotary International Convention in Singapore in 2024.

Outside of Rotary, Chew is active as a local volunteer, having served for nearly three decades with Singapore's People's Association, a government organization that uses a grassroots approach to promote racial and social harmony among Singapore's diverse population. Chew created synergy between People's Association youth groups and Rotary when he helped start community-based Interact and Rotaract clubs that are still active today. For his contributions to Singapore's communities, Chew was awarded the Public Service Award Medal in 2005 and Public Service Star Medal in 2012 by Singapore's president. He also serves as a justice of the peace who volunteers in local prisons, chair of two religious organizations, trustee of three national trust organizations, and honorary consul for the Republic of Slovakia in Singapore.

Chew, who decided to join the Bugis Junction club after reading about the global polio eradication effort in a local newspaper, advocates for the power of partnering to accomplish great things. "As a business person, I strongly believe in creating synergy and leveraging partnerships," he says. "One plus one can be more than two — it can be 11."

Chew is a recipient of the Service Above Self Award. With his wife, Phyllis, he is a member of the Arch Klumph Society Chair's Circle.



Muhammad Faiz Kidwai Rotary International Director 2022-2024

Muhammad Faiz Kidwai is the chair of CG Global, a leading architecture, engineering, urban design, real estate development, and hospitality firm. A 1983 architecture graduate of NED University of Engineering and Technology,

Muhammad was later awarded a research fellowship in conservation in Mostar, Bosnia-Herzegovina, by the Aga Khan Program for Islamic Architecture at Harvard University. A specialist in socially responsive architecture, Muhammad has developed master plans for urban housing projects as well as large urban development and city planning projects.

Muhammad, who joined Rotaract in 1980, is the first Rotary director from Pakistan. In 1986, departing from Karachi on a Rotary Group Study Exchange trip to Canada, Muhammad survived a violent attack during the hijacking of Pan Am Flight 73. "I pledged that, if given another chance to live, I would dedicate my life to the betterment of humanity," he says. "This was the moment that influenced me to join Rotary."

Muhammad joined Rotary in 1987 and became a charter member of the Rotary Club of Karachi Karsaz in 1993. He has been active in polio eradication efforts since Rotary began its work for the cause in Pakistan. In 1997, he established a Rotary Community Corps (RCC) in the suburbs of Karachi, which continues to work with his club on projects.

Muhammad is the founder and chair of the Rotary Pakistan Literacy Mission, whose goal is total literacy and quality education in the country. In a project that encompasses all of Rotary's areas of focus, he led the creation of a model sustainable village in Thatta, near Karachi, for 160 families who had been affected by a flood. He has been involved in supporting Afghan refugees in Pakistan, cochairing an initiative that has assisted more than 50,000 Afghan refugees and working on projects that fight poverty and hunger while promoting the education and empowerment of Afghan girls and women. Muhammad says he would like to see Rotary become the most influential service organization in the region.

Muhammad has received the Service Above Self Award, The Rotary Foundation Distinguished Service Award, and The Rotary Foundation Citation for Meritorious Service. He and his wife, Uzma, are Rotary Foundation Major Donors.



Lena Mjerskaug Rotary International Director 2022–2024

Lena J. Mjerskaug is chief of administrative control at the Norwegian Armed Forces' Defense Staff Norway, where she has worked since 1997. She also owns and operates a farm that has been in her family for generations. Lena

holds a master's degree in economics and business administration from the NHH Norwegian School of Economics and a postgraduate certificate in education from the University of Oslo. Before 1997, she served in the Royal Norwegian Air Force with the aim of becoming Norway's first female fighter pilot. She also worked as a teacher and helped local entrepreneurs start their own businesses.

Lena joined Rotary in 1997 as the first woman in her club and, at the time, its youngest member. She has served Rotary as an End Polio Now zone coordinator, Rotary coordinator, representative to the Council on Legislation, and RI president's representative. She was chair of the Norsk Rotary Forum, a multi-district administrative group, and she also worked on a national Rotary project, Handicamp Norway, a camp that brings together young adults from around the world who have disabilities with others who don't.

Lena, who plans to continue working full time while serving as director, says she wants to lend her experience and skills to minimize the gap between clubs and Rotary International. "Rotary is what the club members create themselves," she says. "No two clubs in Rotary are the same — what works in Norway may not work in Bangladesh. So I'm not representing myself or my region on the Board — I am representing the world."

In addition to her work, her farm, and Rotary, Lena enjoys sports, reading, and learning about the history and culture of the places she visits.

She supports The Rotary Foundation as a Benefactor and a Major Donor. "I give because, even though my contribution will go to a project I may never hear of and help people I will probably never meet," she says, "I know that gift will definitely change someone's life."



Salvador Rizzo Tavares Rotary International Director 2024-2026 Rotary Club of Monterrey Carlos Canseco

Salvador Rizzo Tavares is the founder and CEO of the RIZZO Group, which is dedicated to developing technological solutions for private companies and governments.

Salvador has been a Rotary member of the RC Monterrey Carlos Canseco for 34 years, and in the 2009-2010 period, he was District Governor of the D4130. He has been representative of the president of RI for District Conferences of Latin American countries 13 times.

Also, he was the Rotary Coordinator for the 21A Zone in the period 2015-2018, and Training Leader at the 2020 and 2021 of the RI International Assembly.

Salvador will be a Director of Rotary International and a member of the RI Board in the period 2024-2026. Salvador is a level 4 Major Donor of TRF.

He has 3 children; Anna María, Salvador, and Paulina, and three grandchildren; Enrique, Regina, and Santiago.
