Thank you for the \$2,000 grant to My Very Own Bed from the Edina Rotary Foundation. At current costs, that donation will support the purchase of 13 new bed sets (mattress and frames) for children in our community who would otherwise be sleeping on the floor or sharing a bed with a parent or sibling.

We are also grateful that your membership is interested in and already actively engaged in supporting this work through their volunteer efforts as well. We look forward to building a meaningful, ongoing partnership with the Edina Rotary as we work to build community, one bed at a time.

Because of support from organizations like yours last year, we were able to reach 964 children in 419 families with a new bed and dream kit. This was up from 676 in 2019 and 440 in 2018. The increased impact was particularly important as so many families struggled to provide basic items to their children during this pandemic. With your help, we plan to reach 1200 more children this year.

In their new beds, kids are sleeping better and feeling better. We also regularly hear that they are doing better – at home and at school. Kids are happier, more confident, more independent, and showing up more and focusing better in school. We all do better when we get a good night's rest. We are so happy to be able to support kids' health and wellbeing in this incredibly tangible way.

Thanks for being a part of supporting kids' healthy sleep.
